Brazosport College Year Round Pell Policy Effective April 1, 2010

It is the policy of Brazosport College Financial Aid Office to award financial aid to students attending the Summer 2010 semesters according to the following procedures.

Brazosport College, in adherence to the Higher Education Act of 2008, will determine eligibility of 2009 - 2010 academic year students to receive two (2) scheduled Pell grant awards (200%) in one award year. This program is referred to as "Year Round Pell." Schools participating in the Federal Pell Grant Program are required to adhere to the Year Round Pell regulations and must have a written policy effective July 1, 2010.

Summer 2010 is the transition period during which Brazosport College will begin administering additional Pell grant awards. The transition period offers colleges some flexibility in making this change; therefore, rules for giving second Pell grant awards to students this summer are more flexible than they will be in Summer 2011.

SUMMER 2010

For the Summer 2010 semester, Brazosport College will pay second (2nd) Pell grant awards out of the 2009 – 2010 year. We will begin awarding 2nd scheduled Pell grant awards in mid-April and continue to award eligible students through the end of the Summer 2010 semester.

SECOND SCHEDULED PELL GRANT ELIGIBILITY

The eligibility criteria for a second award in Summer 2010 are:

- Have a complete 2009 – 2010 financial aid file
- Submit [Summer 2010 Financial Aid Request](#) available at www.brazosport.edu/financialaid
- Have used 75% or more of 1st scheduled Pell grant award in 2009 – 2010
- Enroll in a minimum six (6) credit hours
- Meet the [Brazosport College Satisfactory Academic Progress Policy](#) requirements

***Please note:** For **Summer 2010**, no consideration will be given to:

- 2010 – 2011 student eligibility during the cross-over payment period
- academic progression requirements

PART-TIME STUDENTS

Students who have not used 100% of their scheduled Pell grant award for the 2009 – 2010 award year and want summer funding **MUST**:

- Be enrolled in a minimum of three (3) credit hours
- Submit [Summer 2010 Financial Aid Request](#) available at www.brazosport.edu/financialaid
- Meet the [Brazosport College Satisfactory Academic Progress Policy](#) requirements

TRANSFER STUDENTS

Students who transfer to Brazosport College for the Summer 2010 semester **MUST** have:

- Complete 2009 – 2010 Financial Aid File at Brazosport College
- Transcripts from all colleges attended
- Submit [Summer 2010 Financial Aid Request](#) available at www.brazosport.edu/financialaid
- Meet the [Brazosport College Satisfactory Academic Progress Policy](#) requirements
- Adhere to policies stated above for part - time and 2nd Scheduled Pell Grant Eligibility requirements.

NOTIFICATION

The Brazosport College Financial Aid Office will not mail out award letters for summer 2010 financial aid. All awards will be posted on the student's [myBC](#) account when an award is made. Beginning in mid-April, students are encouraged to check their [myBC](#) account regularly to check their award status.
